

Note :- (6) **Candidates must possess a valid Driving License with endorsement for driving Heavy Goods Vehicle or Heavy Passenger Vehicle with Badge throughout all stages of selection, i.e., on the last date of application, Date of OMR Test and Date of Practical Test.**

Note :- (7) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/ SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under Economically Weaker Section category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 03/2024/P&ARD Dated 25.04.2024 as proof of their claim, along with other relevant documents at the time of OTR Verification of original documents.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Copy of answer scripts of the OMR Test held on 26.08.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Invalidation Notification No.ER7-2/14/2025-KPSC Dated 12.11.2025.
